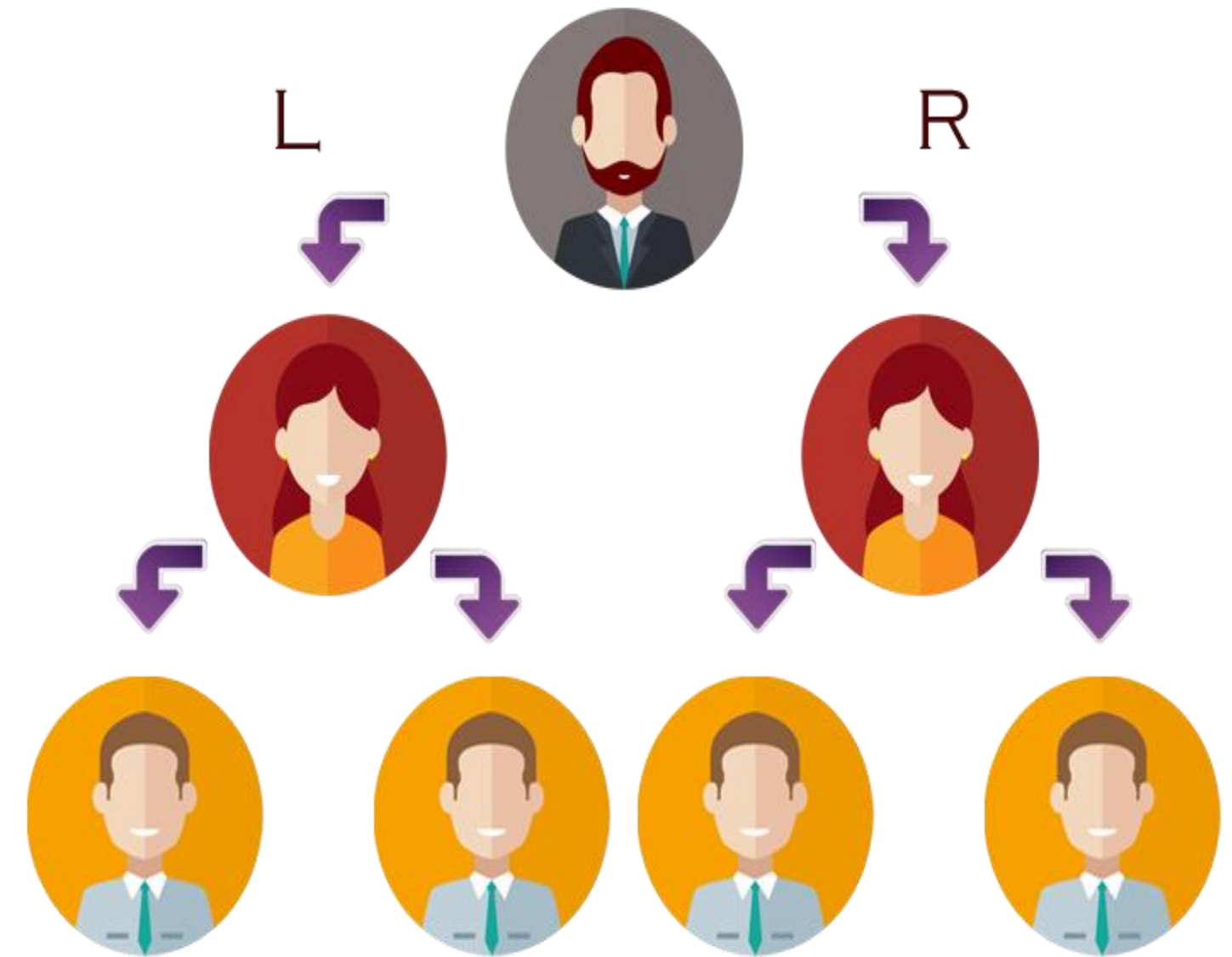

Matching Income

To earn matching income, you must have one active direct member on your left and one on your right, as well as your own active pack. You will receive 12% matching income on 1:1 matched FVP, with a daily cap of ₹10,000.



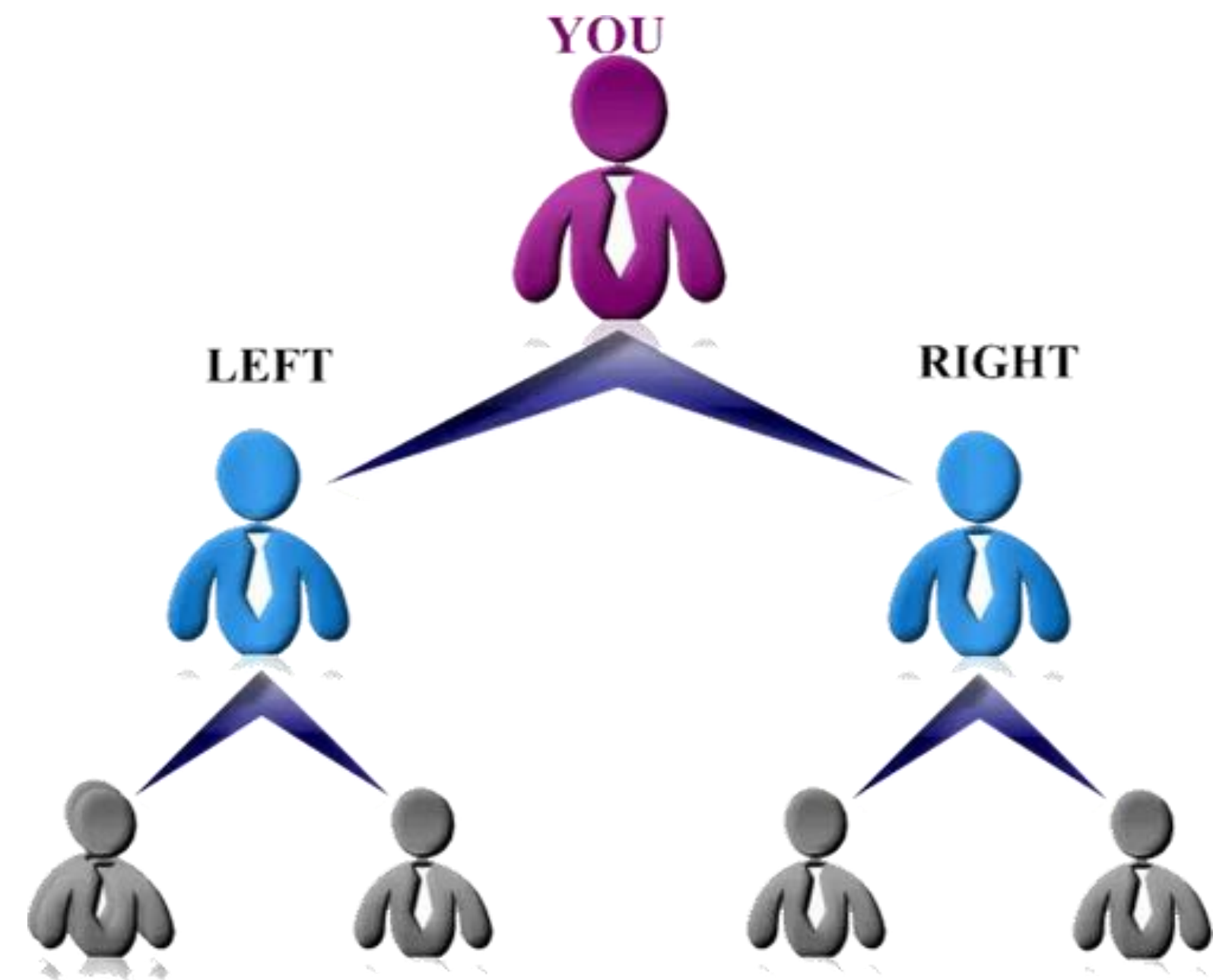
Same Day Bonus



To receive same-day income, you must have at least two direct referrals who have self-activated, and both must be activated before midnight on that day. You'll then earn a ₹500 same-day bonus, and your rank will be upgraded to "Soldier."

Direct Sponsor Matching

A sponsor is entitled to receive a daily override on each direct member's matching income for up to 365 days from that member's activation. Whenever a direct earns matching income, the sponsor earns a percentage of it based on how many active "matches" (one active direct on their left leg paired with one on their right) the sponsor has in total: 2 % once they have 3 matches, 5 % at 6 matches, 10 % at 8 matches, and 12 % at 12 matches. "Active" refers to directs whose IDs have been activated within the past 365 days.



Upline Matching Income

Each day, 10 % of a sponsor's matching-income is set aside and pooled for distribution among all "eligible" directs; to qualify, a direct must have at least two active directs on their left leg and two active directs on their right leg. Once that 2L + 2R requirement is met, every eligible direct shares equally in the 10 % pool, regardless of their individual matching volume.
